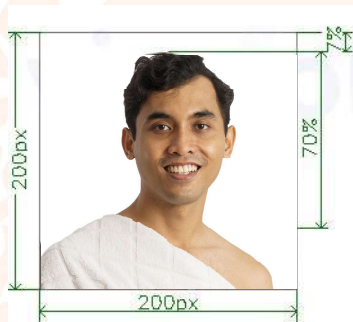

## Saudi Arabia/Umrah/Tourist Visa Form Guidance

### Photo Specifications



### Format (Size):

One identical photograph must be submitted, it should be 200 x 200 in Width and Height and Image Size must be from 5 to 100 Kb. It should show a close up of your face and the top of your shoulders so that your face takes up between 70% - 80% of the face or 1.4" x 1.6" from the chin to the crown of the head. The photo must clearly show the person's facial features in a straightforward position from the tip of the chin to the crown of the head as well as the left and right sides of the face. In the case of voluminous hair, it must be ensured that the head (including the hairstyle) is fully depicted without reducing the size of the face, if possible. The face must be centered in the photo and no more than six months old, to ensure an up to date likeness.

### Background:

The background should be white. The background should not have any pattern. The photo should show only the person to be photographed (no other persons (group pictures) or objects in the photo). No shadows must be shown on the background.

### Expression:

The head of the person photographed should be neither at an angle nor turned (portrait style). Your head must be square to the camera; your face can be slightly rotated and or tilted. Your face and eyes must be straight towards the camera so both ears and cheek is clearly visible.

### Head Wear:

Generally speaking, head wear is not permitted. Exceptions are possible, especially for religious reasons. In such cases, the face must be visible from the lower tip of the chin to the forehead. No shadows should be visible on the face.

### Finally

You'll have to read a declaration below saying and signing that you'll abide by the laws of the KSA and Umrah (no drugs, no alcohol, no indecency while in the Kingdom) thereafter followed by making the payment for your visa. The Visa Fee is 300.00 SAR & Insurance Fee (including VAT) is 95.00 SAR, associated transaction fee is 7.21 SAR and the Total Amount is 402.21 SAR plus our admin fee of £15 unless your visa is within our tour package. Your Visa Application then will be submitted and within minutes, you should receive an email containing your e-visa! Simply print it and take it with you as you travel to Saudi Arabia.

### Declaration:

I acknowledge that all the information I provided are true and reliable. In addition, I pledge to abide to the laws and rules of the Kingdom of Saudi Arabia and respect the customs and Islamic traditions of its people during my stay. I acknowledge my understanding that the specialised authorities in the Kingdom of Saudi Arabia have the right to deny my entry and can send me back to where I came from if I did not comply with the rules and laws; or if the information under which I received my visa are proven to be incorrect.

I am fully aware that all intoxicating substances, narcotic drugs, indecent materials and publications, as well as publications related to any religious beliefs or political tendencies that contradict with Islam are prohibited in the Kingdom of Saudi Arabia.

I am fully aware of the procedures and controls regarding the batch-release and clearance of medicines, containing narcotic or psychotropic substances that are possessed for personal use by patients arriving and departing from The Kingdom. Such procedures and controls are provided in the link below: <https://www.sfda.gov.sa>. I am also aware that if these regulations and controls are transgressed, I shall be subjected to sanctions and penalties stated in the Law of Combating Narcotics and Psychotropic Substances.

I have never been deported from The Kingdom of Saudi Arabia or any other GCC country, nor that I have violated their rules. I have never been deported from The Kingdom of Saudi Arabia or any other GCC country, nor that I have violated their rules. I pledge to Abide to the type of visa I was provided and to its terms and duration; and I shall leave the country before the expiry date specified within the visa. I am also fully aware of the penalty I shall endure in case of my violation to the rules of the Kingdom or to my entry visa; and I shall be subject to the penalty and the execution of the punishments stipulated by the laws regulating the process of handling people entering the Kingdom with visas for Hajj or Umrah and other types of visa issued by the Royal Decree No (m / 42), on 18 / 10 / 1404 H and amended by Royal Decree No (m/9) on 1/5/1420 H. As well as the sanctions on violators of residency and work regulations promulgated by the Council of Ministers resolution No (140) on 6/5/1434 H.

I acknowledge the right of the Saudi authorities to repatriate me from the port of entry at my own expense or deport the Saudi territory after entering it. I acknowledge the right of the Saudi authorities to apply the penalties provided by Law if proven that after I received my visa or residence permit, that I have submitted incorrect papers or documents or provided false statements to any Saudi authority locally or abroad in order to obtain a visa for myself or for someone else; for the reason of entry or to obtain a residence permit or any other official visa. Or being a contributor or partner in providing such information or documents that do not match the truth.

I acknowledge and pledge again that all written information shall be correct and exactly as it is written in my passport that will be used in my travel and entrance to the Kingdom of Saudi Arabia; and I take full responsibility for it. If it is proven otherwise –or my name appears to be included in a list containing the banned people, then my request shall be rejected, or my visa shall be cancelled automatically once granted. Moreover, I acknowledge the right to the Saudi authorities to deport me back to the port of entry at my own expense and I shall not have the right to claim compensation.

I understand that I am not permitted to use the tourist visa for any purpose other than tourism, and that I should not practice any paid or non-paid work related activity, nor perform Hajj during my stay in Saudi Arabia and observe the Laws and etiquettes in Saudi Arabia

I acknowledge that there are no medical treatment purposes behind the visit. To my knowledge, I have not engaged in physical contact with a member of the public affected by the coronavirus (2019-nCoV)

Visa application fees are non-refundable (meaning after you get your visa you will not be able to cancel and receive a refund)

I have read and agree to Privacy Policy, Terms and Conditions. The duration of stay is 90 days upon entry in Saudi within the validity of the eVisa which is one year. Once the 90 days has been consumed, there will be no extension nor renewal of the eVisa until the expiry of the validity of the eVisa (one year) It's prohibited for non-Muslims to access the two holy sites of Mecca and Madina.

If you wish to perform Umrah rituals, pray in the Grand Mosque or visit and pray in the Prophet's Mosque and Al Rawdah Al Sharifah, then you must obtain a permit through the "Nusuk" application, noting that you cannot enter without having the permit. ## **Our Agreement**

### **Your application**

The Kingdom of Saudi Arabia ("KSA") has introduced an electronic visa service ("eVisa"). The eVisa is a multi-entry electronic travel authorization that allows citizens from eligible countries to visit KSA for a short-term stay. The eVisa has been designed to speed up the process of getting a visa for KSA. The eVisa service is operated by Ministry of Tourism

1. If your eVisa application is accepted, we will be sending you the eVisa as an email attachment.
2. If we are unable to accept your application for whatever reason, we will use reasonable efforts to inform you of this by email.
3. Once you have submitted an application for an eVisa, you will not be able to cancel it or request a refund under any circumstances.
4. Applicants that are not successful (for whatever reason) will not be entitled to a refund of any application fees paid.
5. We will issue an invoice for your transaction.
6. In order for us to provide the Service, you must provide us with true and accurate information when submitting your application. Any application containing false or misleading information will be rejected. We reserve the right to share with the authorities any application that we suspect of containing false or misleading information provided.
7. Approval of an eVisa shall be at the sole discretion of the MT and any applicable authority and / or regulator.
8. Payment of an application fee does not guarantee approval of an eVisa.
9. Holding an eVisa does not guarantee entry to KSA. Entry to KSA shall remain subject to the relevant individual meeting the conditions on arrival at the border and an individual's entry to KSA shall remain at the discretion of an Immigration Officer.

### **Price and Payment**

- 1 The price of the Service will be set out on the Website and at the time of payment during the eVisa application process. The fee for the eVisa may be amended from time to time at the sole discretion of Dawa Travels Visa Department
2. VAT will be charged at the applicable rate and will be payable by the applicant as part of the fees.
3. £15 Admin Fee are applicable and is paid in GBP

### **eVisa validity**

1. The eVisa will be valid for one year from the date of issuance.
2. The eVisa will be valid for multiple entries, unless stated otherwise on the specific eVisa.
3. The maximum length of stay allowed under the eVisa is 3 months.
4. If you are granted an eVisa, it cannot be extended.
5. If the eVisa expires before entry to KSA, you must apply again and another application fee must be paid.
